WATER USERS AGREEMENT

This agreement between Rural Water District, and _

a member of the District or Company, hereinafter called the Member.

The District or Company shall furnish, subject to limitations hereinafter provided for, such quantity of water for domestic and farmstead purposes as the Member may desire in connection with his occupancy of his property located

The Member shall install and maintain at his own expense a service line which shall begin at his property line and extend to the dwelling and other portion of his premises.

The Member's service line shall connect with the distribution system of the District or Company at the nearest place of desired use by the Member, provided the District or Company has determined in advance that the water system is of sufficient capacity to permit delivery of water at that point.

The Member shall pay for such water at such rates, and place as shall be determined by the Directors.

The Member shall not connect any additional dwelling or residence to be served through his meter.

The Member agrees that he will make no physical connection between any private water system and the Water System of the District or Company. The District or Company may at any reasonable time make inspection to enforce this provision. Violation of this provision shall be grounds for disconnection of the service.

The District or Company shall purchase and install a cutoff valve and may also include a water meter, in each service. Such cutoff valve and water shall be installed within three (3) feet of the distribution system. The District or Company shall have exclusive right to use such cutoff valve and water meter and to turn it on and off.

The District or Company shall have final jurisdiction in any question of location of any service line connection to its distribution system; shall determine the allocation of water to Members in the event of a water shortage; may shut off the water to a Member who allows a connection or extension to be made to his service line for the purpose of supplying water to another user.

The failure of a Member to pay water charges duly imposed shall result in the automatic imposition of the following penalties:

A. Non-payment within fifteen days from the date due will be subject to a penalty of ten (10) percent of the delinguent account.

B. Non-payment within thirty days from the due date will result in a delinquent charge as determined by the Board of Directors and cut off of services from the Member's property.

C. In the event it becomes necessary for the District or Company to shut off the water from a Member's property, all charges owed shall be paid prior to continuation of services.

D. Non-payment for sixty days after original due date will allow the District or Company to remove the meter and cause forfeiture of initial tap fee. The Member will allow the District or Company to terminate his service and in such event, the Member shall not be entitled to receive, nor the District or Company obligated to supply any water under this agreement. If reinstatement is requested after this date, a fee will be charged at the discretion of the Board of Directors.
